

# Service Name: Registration/ Renewal under The E-waste Management Rules 2022

Registration under e-waste management is the official process by which producers, manufacturers, refurbishers, dismantlers, and recyclers of electrical and electronic equipment in Goa become authorized to manage their e-waste in accordance with the E-waste (Management & Handling) Rules, 2011. To legally manage e-waste in Goa, organizations and businesses involved in the production, refurbishment, sale, and recycling of electronic goods must register with the Goa-Pollution Control Board (Goa-PCB) and obtain necessary approvals.

#### CIRCULAR

The Board at its 157<sup>th</sup> meeting held on 09<sup>th</sup> January, 2024, had approved for Amending of fees for authorization issued by the Board under (a) Hazardous Waste Authorization (b) E-Waste authorization (c) Municipal Solid waste Authorization (d) Plastic waste Registration as under:

a.	Hazardous Waste Authorization	Rs. 15,000/- Validity 3 years for issue of such authorization.		
b.	E Waste authorization	Rs. 15,000/- Validity 3 years for issue of such authorization.		
C.	Municipal Solid waste Authorization	Rs. 15,000/- Validity 3 years for issue of such authorization.		
d.	Plastic waste Registration	Fresh registration with validity of one year of Rs. 5,000/- and subsequent renewal application of Rs. 15,000/- for three years.		

Further, penalty of 50% shall be imposed on Authorization/Registration fees payable, if the application is not submitted by the date, as prescribed under the concerned Rules for the purpose of renewal.

This Circular supersede the earlier Circular issued by the Board by vide no. 1/8/13-PCB/Vol.XIII/Admn/19795 dated 04/02/2021, except for Battery waste authorization.

#### **MEMORANDUM**

In furtherance of the notification No.3/02/2015-IND/64 dated 25/01/2021issued by the Department of Industries, Government of Goa, the Goa Investment Promotion and Facilitation Board (Goa-IPB), State's implementation agency for Ease of Doing Business, hereby issues the following mandates as outlined below:-

- 1) Further to point 3 of the above mentioned notification, the online system for Public Consultation has been implemented in the State to ensure the following for all proposed regulations in the State:
  - i. Legal basis
  - ii. Necessity
  - Business friendly policies
  - iv. The drafts of proposed acts, rules or regulations should be made available for a minimum period of 30 days

All departments of the State Government are to note the above four points while drafting and proposing any legislation, rules or regulations.

- 2) Furthermore, the online single window system and all online services should have the following features:
  - i. End-to-end online application and submission
  - Online payment and document submission
  - Online status tracking and department comments
  - Online certificate issuance and download iv.
  - Facility for online verification of certificates/ licenses/ permits by third parties

All Departments of the State Government and their IT vendors concerned should make sure that any service made online should have above mentioned features for the online systems used and developed by them.
